

Supplement Sheets

- Selling a total of 300 embryo transfer spots. (2) lots of 50, (4) lots of 25, (10) lots of 10. Selling Choice of any Lots
- There will be 3 calving windows with a 4th if needed
 - 1st window- end of January- First week of February **Estimated 175 Transfers**
 - 2nd window- Middle end of February **Estimated 75 Transfers**
 - 3rd window- Middle of March **Estimated 50 Transfers**
 - (If Needed)4th window- Beginning of April.
- Calving windows are filled by the order in which they are bought. Ex. First lot purchased will be the first embryos in on the 1st window and the last lot purchased will be last embryos to go in 3rd or 4th slot
- If a client is to buy more than one lot in the sale, we will average the price between all lots purchased. See Purchase Scenarios below.
- Any Clients of Premier Genetics that produce conventional or IVF embryos at the Warsaw Embryo Facility will receive \$50 off weaned calf.
- Any Clients of Premier Genetics that produce conventional or IVF embryos at the Warsaw Embryo Facility will receive a 10% discount on daily donor housing.
- Payment Terms and Protocol: 15% down payment due after 45 days of sale this 15% down payment is applicable to the final invoice at weaning. Final payment is made at weaning and must be paid in full prior to picking up of weaned calves.
- All veterinary costs will be charged to Customer which include but limited to c-sections, breached calves, or emergency surgeries.
- Any recipients that may perish during calving due to extreme birth weights will be reimbursed to Premier at market rate.
- 15% downpayment of lots purchased will be required within 45 days to hold the slots. If payment arrangements are not then made, slots will be forfeited.
- The downpayment will go towards future final weaned calf cost.
- All Embryo Implant cost is at the buyer's expense
- Embryos must be on site a minimum of 14 days prior to implant unless other arrangements are made prior.
- 90 day bred recipients can be purchased at a set price of \$5500, recipient will be delivered post weaning of current calf, if applicable.
- All Shipping and Delivery Costs (embryos and calves) will be at the Buyers expense
- Embryos not implanted or sent for future implants will be subject to standard storage rates.
- Premier Genetics Cooperative Herd Contract to be executed within 7-10 after auction.

Purchase Scenario A

Lot is purchased for \$4,500@10 slots.

Down payment- 15% of total price is \$6,750 due within 45 days of sale

\$75@ 10 embryos transfer fee due within 30 days of implant (\$750)

Weaning time 6 @ \$4500 = \$27,000 apply 15% auction deposit -\$6,750.

Total due at Weaning = \$20,250 prior to pick up/delivery of calves

Purchase Scenario B (Multi Spot Purchase)

First lot is purchased for \$4,500@10 slots.

Second lot is purchase for \$4,000 @ 25 slots

Average Price per weaned calf will be \$4,142.86

Down payment- 15% of total price is \$21,750 due within 45 days of sale

\$75@ 35 embryos transfer fee due within 30 days of implant (\$2,625)

Weaning time 21 @ \$4,142.86 = \$87,000 apply 15% auction deposit -\$21,750.

Total due at Weaning = \$65,250 prior to pick up/delivery of calves
