

DRAFT CONTRACT/AGREEMENT

Premier Genetics Cooperative Herd Agreement

This agreement entered into on _____(date) between Premier Genetics LLC and _____(Customer) is a legally binding agreement for Cooperative Herd/Weaned Calf Program.

Terms of Cooperative Herd Agreement:

1. Embryos will be provided by Customer for implant a minimum of 14 days prior to implant.
2. Customer is responsible for all implant fees.
3. Premier Genetics will cover the cost for drug fees associated with transfer of embryo into recipient.
4. All Vaccinations (see Exhibit A), treatment for sick calves will be covered by Premier Genetics.
5. All veterinary costs will be charged to Customer which includes but limited to c-sections, breached calves, or emergency surgeries.
6. Any recipients that may perish during calving due to extreme birth weights, as determined by a veterinarian, will be reimbursed to Premier Genetics at market rate.
7. Calves will be creep fed 60 days prior to weaning; feed costs to be covered by Premier Genetics.
8. No pregnancy rate guarantee provided by Premier Genetics
9. No calf crop viability percentage guarantee provided by Premier Genetics
10. All Embryo shipping and storage fees will be the responsibility of the Customer.
11. Calves will be picked up within 45 days of weaning at a location provided by Premier Genetics. Calves to be weaned at approximately 205 days unless other arrangements are made between Premier Genetics and Customer
12. All trucking and related expenses are the sole responsibility of the Customer.
13. Any head remaining on site over 45 days post weaning are subject to a \$7 head per day yardage fee.
14. The fee of _____per weaned calf is due for all live calves' post weaning and must be paid prior to pick up/delivery.
15. Any culls the Customer expresses they do not want shipped to Customer's selected location, we will haul to local sale barn on Customer's behalf for \$3.00 a mile delivery charge. Customer is still subjected to pay coop fees for the culled animal.
16. Any pregnancies sold prior to calving will be an additional \$5500 for the recipient confirmed pregnancy, payable at delivery/shipping of confirmed pregnant recipient.
17. Premier Genetics assumes no liability for loss of pregnancies, calves, donors or embryos.
